The Executive Members of the BGC are asked to submit the name of one Daughter who would like to serve as a Grand Bethel Officer (GBO). They may also submit the name of a Daughter to be drawn as an Alternate Floor Officer in the event insufficient names are submitted for GBOs. Additionally, the name of a Daughter who proficiently plays an instrument may be submitted for the Office of Grand Bethel Musician. Please note: if a Grand Bethel Officer is selected from your Bethel and the Daughter accepts the position, the name submitted for the office of Grand Bethel Musician will be withdrawn unless there are no other qualifying musicians in the draw.

Please duplicate both pages of this Form. One Form will be needed for the Grand Bethel Officer, one for the Grand Bethel Musician, and one for the Alternate Grand Bethel Floor Officer. Each Registration form (both pages) **must** be accompanied by the GBO Agreement and Permission and Media Release Form and returned to Donna Daiss, Chairperson of the Grand Bethel Committee, 2910 Lake Park Lane, Hastings, Nebraska 68901. The forms must be **postmarked on or before May 10, 2010**.

The basic criterion for selection to a Grand Bethel Office is listed below:
