MNJD Contestant Sponsor and Patron Information

The Miss Nebraska Job's Daughter Pageant is self-sustaining, each contestant is expected to provide a sponsor and patrons for the pageant. Only through these fund raising efforts are we able to make the pageant a memorable experience for the contestants and audience.

Sponsor: A sponsor is the person or organization that pays the contestant's \$25.00 registration fee. This may be the contestant's Bethel, parents or any other entity willing to provide the fee.

The sponsor will be listed in the pageant program.

Patrons: Patrons contribute a \$5.00 donation in honor of the contestant and will be listed in the pageant program. The funds received from the patrons make up the joint fund raiser for the pageant and the contestant's Bethel. *From each patron's \$5.00 contribution, \$4.00 is sent to the Grand Guardian Council and \$1.00 is retained by your Bethel to use as they wish.*

Minimum Contribution: In figuring our budget, we estimated that each contestant would get a minimum of 30 patrons. This would make the patronage of each contestant \$120.00 and bring your Bethel a \$30.00 donation as well. Because the funds received from patrons are so vitally important to the operation of the MNJD Pageant, **contestants who do not meet this minimum requirement will receive a -5 point deduction from their total competition score.** Interview and pageant judges will receive information regarding the total number of patrons and total money raised for each contestant and may use this information when deciding on the "Overall Impression" score.
